

INVESTMENT OBJECTIVE

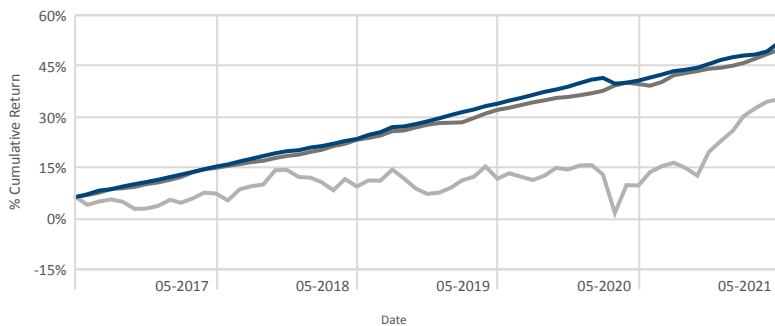
The Noble PP BCI Flexible Fund is a flexible portfolio that aims to provide investors with consistent inflation-beating total returns, while minimising downside risk with a specific focus on capital growth.

INVESTMENT POLICY

In order to achieve its objective, the investments normally to be included in the portfolio may comprise a combination of assets in liquid form, money market instruments, interest bearing securities, bonds, debentures, corporate debt, equity securities, property securities, preference shares, convertible equities and non-equity securities. The portfolio may invest in participatory interests or any other form of participation in portfolios of collective investment schemes or other similar collective investment schemes. The portfolio may from time to time invest in listed and unlisted financial instruments. The manager may also include forward currency, interest rate and exchange rate swap transactions. The portfolio may make active use of derivatives to reduce the risk that a general decline in the value of equity, property and bonds markets may have on the value of the portfolio. The investment manager introduced an internal mandate restriction whereby the equity exposure is capped at maximum 50% of the portfolio's net asset value.

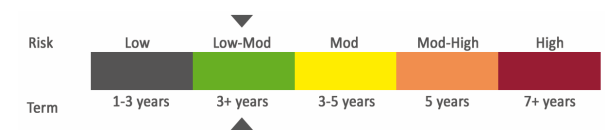
