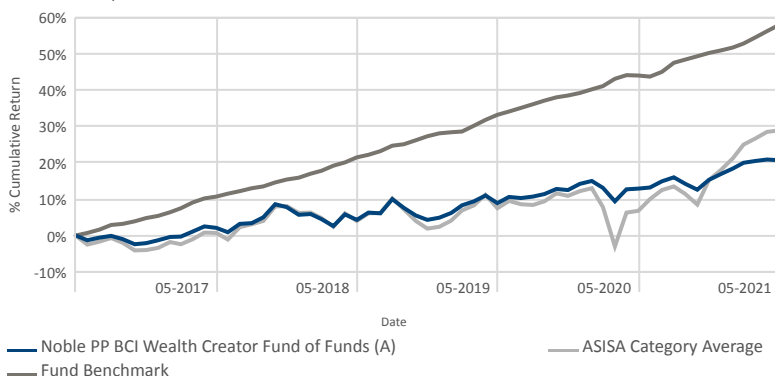
The Noble PP BCI Wealth Creator Fund of Funds is an aggressive managed fund of funds with a primary investment objective to deliver capital growth.

INVESTMENT POLICY

The portfolio complies with prudential investment guidelines to the extent allowed for by the Act. Investments to be included in the portfolio will, apart from money market instruments and cash, consist of participatory interests and other forms of participation of local and global collective investment schemes, which is consistent with the portfolio's primary objective, investing in equity securities, property securities, non-equity securities, money market instruments, preference shares, listed and unlisted financial instruments, bonds and other interest-bearing instruments and securities.

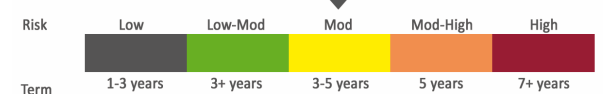

Moderate Risk

- This portfolio has a balanced exposure to various asset classes. It has more equity exposure than a low risk portfolio but less than a high-risk portfolio. In turn the expected volatility is higher than a low risk portfolio, but less than a high-risk portfolio.
