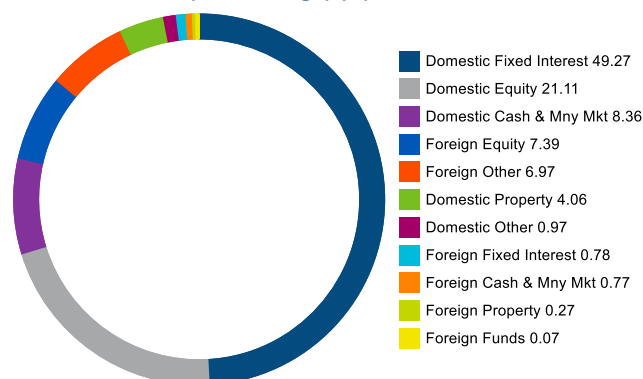

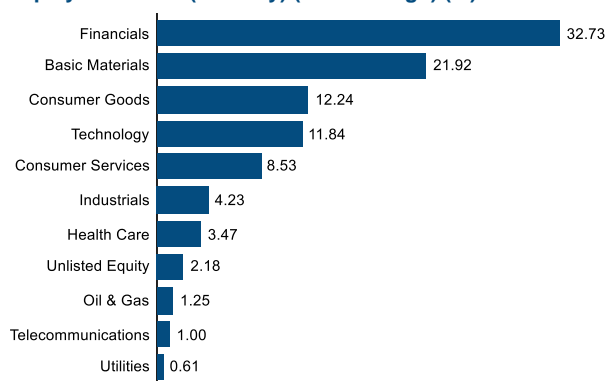

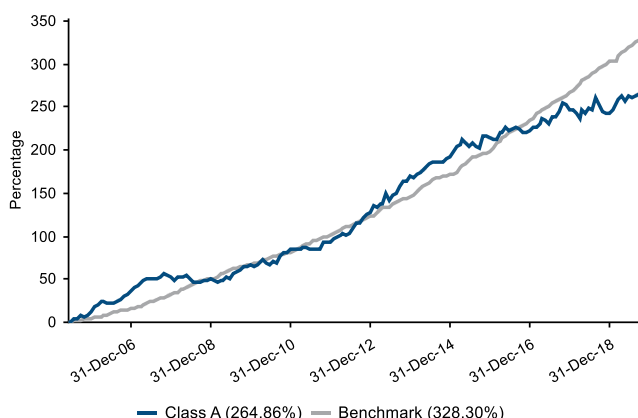

## Market overview

### World Economy

The US Federal Reserve decided to cut the target interest rate to a range of 1.75% to 2%, highlighting the strength of the labour market but weakness in fixed investment. The US Federal Reserve downplayed expectations that it may lower interest rates further after the 25-basis-point cut. In September, US consumer confidence dropped more sharply than the market expected, to 125.1 index points, largely as a result of the hike in trade tariffs. A US manufacturing index fell to a 10-year low in September, prompting sharp losses on US markets, while the World Trade Organization (WTO) also slashed its global trade growth forecast for 2019 to 1.2%, from 2.6% previously. In August, China's industrial production growth fell below 5% for only the second time since February 2002, at an annualised 4.4%. The data is likely to prompt further stimulus measures from the government. Retail sales in China rose 7.5% in August, below market expectations of 7.9% growth, as spending on automobiles and jewellery was even weaker than in July. European Central Bank president Mario Draghi called for euro-area-wide fiscal stimulus aimed at boosting investment, saying the latest steps in this direction are insufficient.

### SA Economy

South Africa's consumer inflation rose by 4.3% in August, compared to 4% in July. This is slightly higher than expected. The Reserve Bank kept the interest rate at 6.5%. The Bank revised its inflation forecast for 2019 down to 4.2%, from 4.4% previously. South Africa's retail trade increased 2.0 percent year-on-year in July 2019, easing from a 2.4 percent rise in the prior month and missing market expectations of a 2.6 percent gain. SA's trade balance swung into a larger-than-expected surplus of R6.84bn in August, according to data from the SA Revenue Service. The Absa PMI fell to 41.6 points in September, from 45.7 previously. The latest figure is far below analyst expectations of an increase to 46.5 points, according to a Bloomberg consensus. The September 2019 new passenger car market sales reflected an increase of 1,1% compared to the new cars sold in September last year. The September 2019 export sales reflected a decline of 3,0%, compared to the vehicles exported in the same month last year. For the first nine months of the year, vehicle exports, are now 18,8% higher than the corresponding period last year.

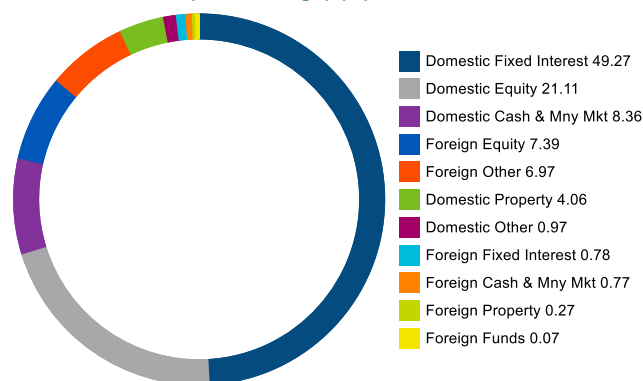

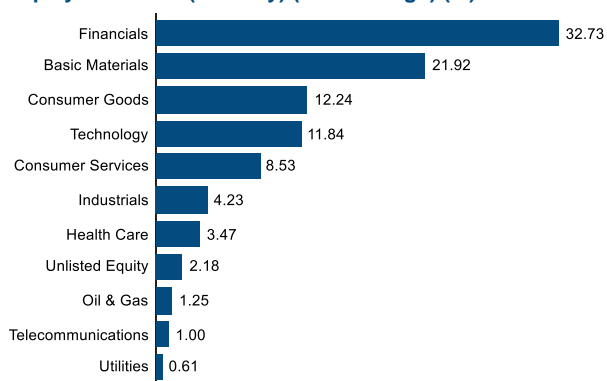

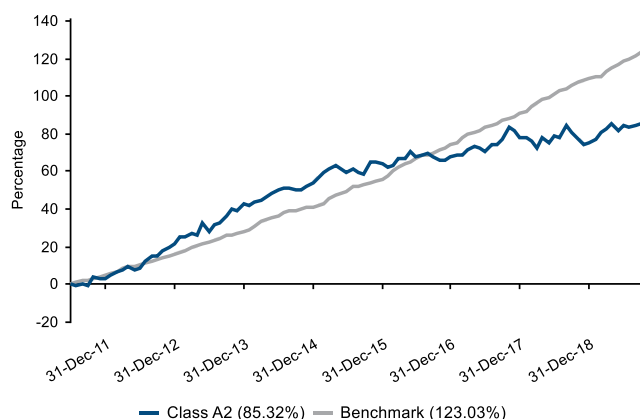

## Market overview

### World Economy

The US Federal Reserve decided to cut the target interest rate to a range of 1.75% to 2%, highlighting the strength of the labour market but weakness in fixed investment. The US Federal Reserve downplayed expectations that it may lower interest rates further after the 25-basis-point cut. In September, US consumer confidence dropped more sharply than the market expected, to 125.1 index points, largely as a result of the hike in trade tariffs. A US manufacturing index fell to a 10-year low in September, prompting sharp losses on US markets, while the World Trade Organization (WTO) also slashed its global trade growth forecast for 2019 to 1.2%, from 2.6% previously. In August, China's industrial production growth fell below 5% for only the second time since February 2002, at an annualised 4.4%. The data is likely to prompt further stimulus measures from the government. Retail sales in China rose 7.5% in August, below market expectations of 7.9% growth, as spending on automobiles and jewellery was even weaker than in July. European Central Bank president Mario Draghi called for euro-area-wide fiscal stimulus aimed at boosting investment, saying the latest steps in this direction are insufficient.

### SA Economy

South Africa's consumer inflation rose by 4.3% in August, compared to 4% in July. This is slightly higher than expected. The Reserve Bank kept the interest rate at 6.5%. The Bank revised its inflation forecast for 2019 down to 4.2%, from 4.4% previously. South Africa's retail trade increased 2.0 percent year-on-year in July 2019, easing from a 2.4 percent rise in the prior month and missing market expectations of a 2.6 percent gain. SA's trade balance swung into a larger-than-expected surplus of R6.84bn in August, according to data from the SA Revenue Service. The Absa PMI fell to 41.6 points in September, from 45.7 previously. The latest figure is far below analyst expectations of an increase to 46.5 points, according to a Bloomberg consensus. The September 2019 new passenger car market sales reflected an increase of 1,1% compared to the new cars sold in September last year. The September 2019 export sales reflected a decline of 3,0%, compared to the vehicles exported in the same month last year. For the first nine months of the year, vehicle exports, are now 18,8% higher than the corresponding period last year.
