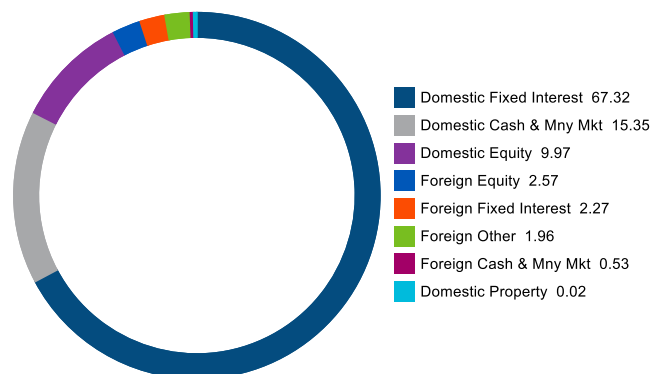

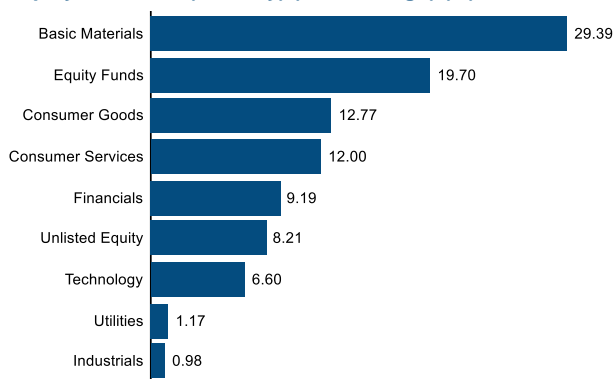

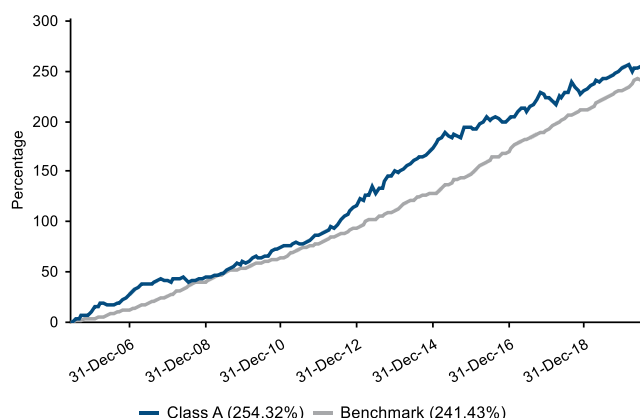

## Market overview

Characteristics of the first quarter of 2020 was the following:

- A positive outlook and start on the JSE beginning of January
- A drop in interest rates to promote growth
- A petrol price drop in April 2020

Unfortunately, all was not to be as good as we anticipated, as a string of negatives started to unfold:

- A fall of  $\pm 30\%$  in Equity markets starting mid-January, as COVID-19 proved to be worse than expected
- A flight from emerging market paper, as bond prices fell heavily under selling and yields soared when Moody's downgraded SA paper to junk status
- A deteriorating Rand and subsequent Rand losses
- SA bonds no longer featuring in the World Government Bond Index
- Chinese economic growth hit by COVID-19 – bad for world trade
- Country Lockdowns hurting SME's as well as employment

To try to keep up liquidity as bonds were selling off, the SARB started buying SA bonds to prop up the market but unfortunately, this is not a long-lasting solution. SA might have to look at the BRICS Contingent Reserve for relief or maybe even approach the IMF.

Where does all this leave the investor? Noble foresaw difficult conditions and therefore, stuck to a philosophy of capital preservation and not to gamble with, especially pensioner portfolios.

This conservative approach is bearing fruit, capital is being preserved and we will continue to safeguard clients' investment portfolios.

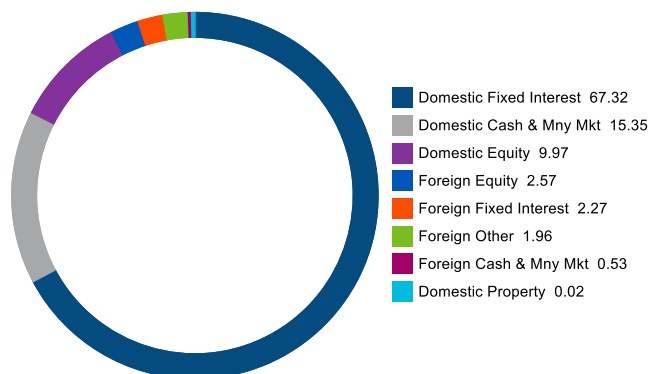

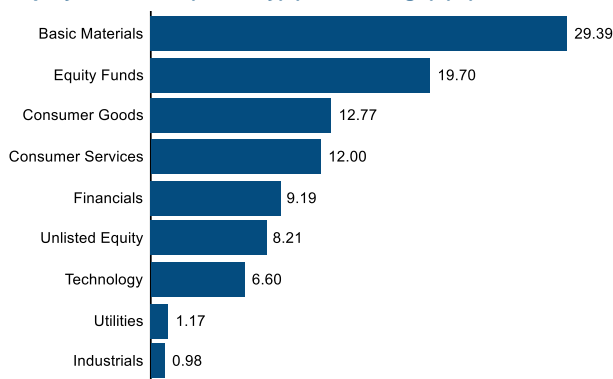

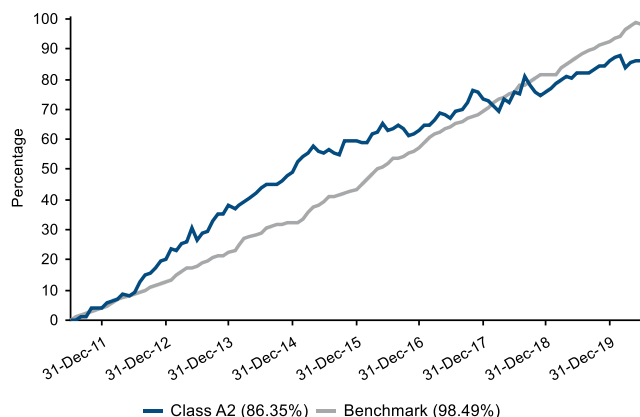

## Market overview

Characteristics of the first quarter of 2020 was the following:

- A positive outlook and start on the JSE beginning of January
- A drop in interest rates to promote growth
- A petrol price drop in April 2020

Unfortunately, all was not to be as good as we anticipated, as a string of negatives started to unfold:

- A fall of  $\pm 30\%$  in Equity markets starting mid-January, as COVID-19 proved to be worse than expected
- A flight from emerging market paper, as bond prices fell heavily under selling and yields soared when Moody's downgraded SA paper to junk status
- A deteriorating Rand and subsequent Rand losses
- SA bonds no longer featuring in the World Government Bond Index
- Chinese economic growth hit by COVID-19 – bad for world trade
- Country Lockdowns hurting SME's as well as employment

To try to keep up liquidity as bonds were selling off, the SARB started buying SA bonds to prop up the market but unfortunately, this is not a long-lasting solution. SA might have to look at the BRICS Contingent Reserve for relief or maybe even approach the IMF.

Where does all this leave the investor? Noble foresaw difficult conditions and therefore, stuck to a philosophy of capital preservation and not to gamble with, especially pensioner portfolios.

This conservative approach is bearing fruit, capital is being preserved and we will continue to safeguard clients' investment portfolios.
