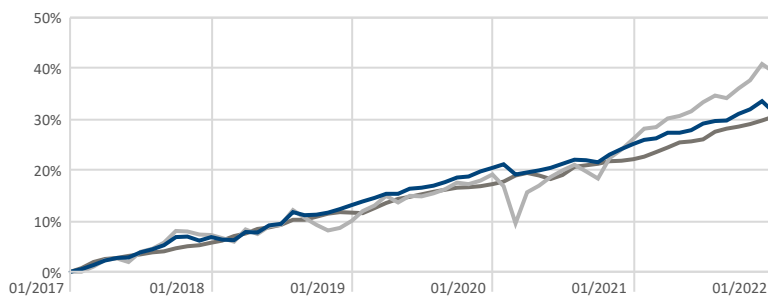
INVESTMENT POLICY

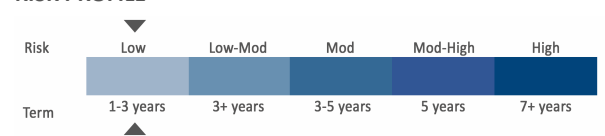

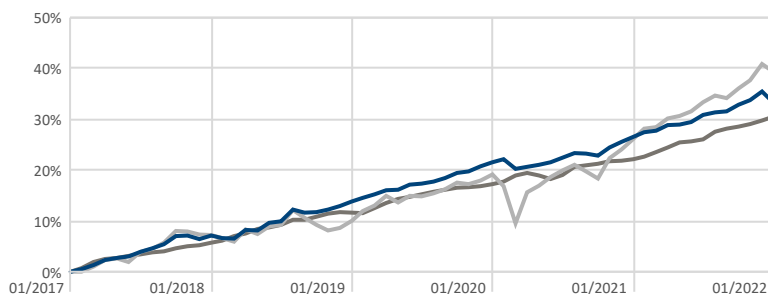

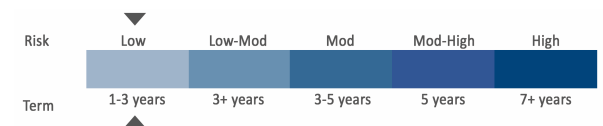
