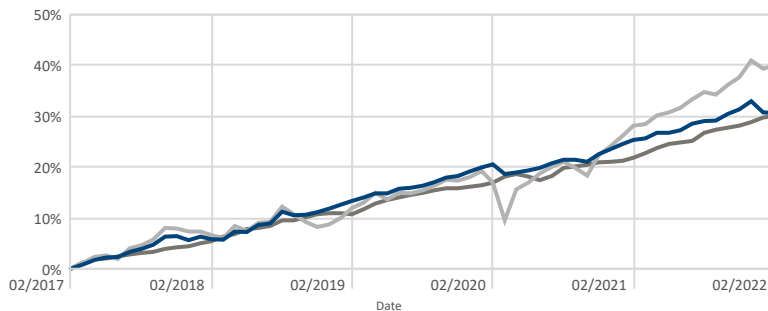
**INVESTMENT POLICY**

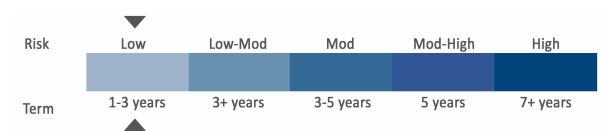

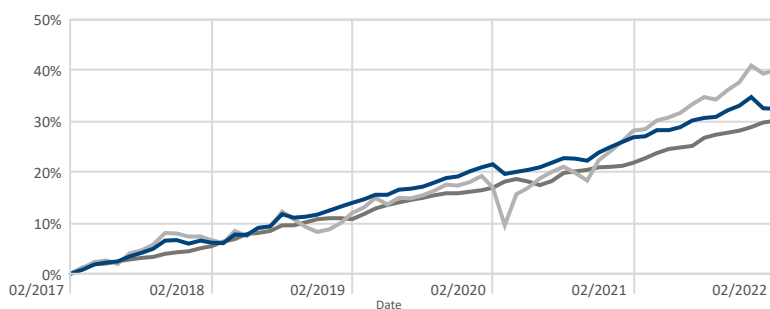

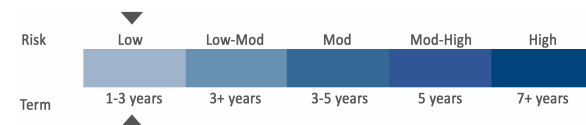
