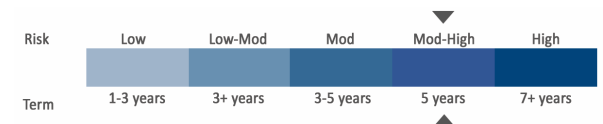

## RISK PROFILE



### Moderate - High Risk
